6. Reports of the Executive Committee

6.1. President report by Marcelle Desmornes

The President gave an overview of our bargaining unit activities and highlights since the last AGM; summarized her role locally, her involvement at the provincial level and thanked members for attending the AGM.

6.2. Vice-Presidents -

Jonathan Degan – presented highlights of 15 years + of being part of the executive; highlighted the mentorship received from the provincial executive secretariat liaison Marc Robillard

Michele Lamarche - provided clarification on committees and vacant positions.

6.3. Chief Negotiator & Grievance Officer presented by Karine Coen

The grievance officer upholds the union responsibility that the collective agreement is respected, and members are protected in relationship with the employer.

56 grievances were filed for 2020 – 2022 based on abuse of management rights, harassment and discrimination, disciplinary, regularization of new functions and work hours.

7. Report of the Treasurer and Budget presentation by Yolette Assad, Treasurer

The financial statement of our bargaining unit for the period from July 1, 2022

to June 30,2023 as well as the budget for the 2023-2024 year are presented.

Questions on bank fees and salary of the new fully released Vice-President were adequately responded to. Suggestion was made to provide a breakdown of "other expenses" in future budgets

8. Report by Jonathan Degan, Vice-President on the SSUO reserve fund:

balance for 2022: \$ 142 457; 2022

September deposit of \$ 250 000;

balance on 2023 : \$ 402 260 - no risk investment at 4.29%

Jonathan Degan recommended that given the operational budget surplus, it is reasonable to provide \$ 10 000 each year.

9. Report: Provincial Executive by Paul Caccamo

Update on Bill 124: The Ontario Superior Court ruled that Bill 124 is unconstitutional and a violation of the Canadian Charter of Rights and Freedoms; the provincial government appealed this decision and there is hope that the appeal would be rejected. In that case there is a possibility that workers could be eligible for retroactive pay.

Vice-President Jonathan Degan, confirmed there is reopening clause in PSUO-SSUO collective agreement.
